International Association of Chiefs of Police (IACP) Forensic Committee Meeting

In late October, the IACP held their annual conference in Orlando, Florida. During that conference, the annual business meeting of the IACP's Forensic Committee was held. The committee announced the recipients of the Vollmer Awards for Excellence in Forensic Science and conducted other business. Ray Prime, co-chair of the committee for the past several years announced that he resigned that position due to his retirement from the Forensic Science Centre in Toronto, Canada. Stephanie Stoiloff, the crime laboratory director for the Miami-Dade Police Department was chosen as the new co-chair of the committee.

The IACP is becoming increasingly concerned with the issue of wrongful convictions. Last year, the Investigative Committee of the IACP held a panel discussion regarding this matter and I represented the forensics community on that panel. This year, the committee held a special meeting to discuss the issue of wrongful convictions. Many factors contribute to those wrongful convictions; included are false confessions, forensic errors, wrong eyewitness identifications, faulty prosecutions and others. The committee brainstormed ideas that could be turned into action items for both the committee and the IACP leadership. No specific recommendations were adopted but this issue is not going to go away and will continue to rise on the radar screen of the IACP.
